# **Jenny Collins - Chehalis Foundation**

- Foundation is focused on two major projects. The first is a tennis facility and wrestling
  facility located near the elementary school. They hope to receive \$850,000 in state
  legislative support. They are partnering with many groups.
- The foundation is also planning the renovation of the WF West baseball fields, which is a \$1.6 million project. \$1 million is already raised. These projects do include funds for maintenance.
- Jenny would like to talk to CCRT at a later date about the success of the Student Achievement Initiative. Annalee and Jenny will coordinate.

## Jill Anderson - City of Chehalis Manager

- Jill mentioned and applauded the partnership with the Chehalis Foundation.
- Kate McDougall was sworn in as the newest member of the Chehalis City Council this month.
- Councilman Ketchum has been appointed Mayor.
- There is an opening for a seat on the City Council and applications are due February 2 at 5:00 pm.
- The recent flooding caused the worst damage on 3<sup>rd</sup> Street and Chehalis Ave, Shoreline and Louisiana. The city is doing an assessment of local areas affected by the flooding. People who need help should visit the Lewis County website for more information. The City will be holding cleanup events in the future at city parks.
- City is closing out several major projects. The work on Pacific Avenue is finished with only streetlight installation remaining. Streetlights were backordered. The fire station site is being developed near the intersection of Chamber of Commerce Way and State Avenue.

- Safety and Security Grant coming this year, helping secure local businesses.

# **Organization - Annalee for Michele Gallagher**

Organization Committee is gearing up for B&O tax donation season. This program
allows local businesses to direct their tax dollars to their local community. Businesses
receive a 75% tax credit the next year on toward their B&O taxes. The available state
cap of funds is higher this year which means CCRT has the ability to raise more money
this year towards projects enhancing and promoting Chehalis growth.
